Definitions

EDUCATIONAL INSTITUTION: An accredited academic institution.

ADVISOR: The person who serves as the primary point of contact for all communications involving this agreement. The ADVISOR must have a research-related affiliation with an EDUCATIONAL INSTITUTION that holds an ACADEMIC LICENSE. The ADVISOR is the person primarily responsible for the use of the data in the project.

STUDENT: The person using the data for a (thesis) project which is being advised by ADVISOR.

ACADEMIC LICENSE: The GERMANET DATA ACADEMIC RESEARCH LICENSE AGREEMENT signed by the LICENSER and the head of /a chair at the ADVISOR'S EDUCATIONAL INSTITUTION.

Purpose

This (THESIS) PROJECT TERMS OF USE AGREEMENT must be signed by the ADVISOR of a STUDENT who uses GermaNet for (thesis) research. It sets out the requirements and responsibilities of the ADVISOR and ensures that all parties concerned understand their obligations to protect copyrighted data.

In order to use the resource for (thesis) research, an ACADEMIC LICENSE must be obtained by the head of the institute or a chair, this agreement must be signed by the ADVISOR, and a (THESIS) PROJECT NON-DISCLOSURE AGREEMENT must be signed by the STUDENT.

The ACADEMIC LICENSE and the (THESIS) PROJECT NON-DISCLOSURE AGREEMENT are attached to this (THESIS) PROJECT TERMS OF USE AGREEMENT and form part of it.

(Thesis) Project Terms of Use Agreement

1. The ADVISOR must inform the STUDENT of the copyrights on the primary data and the linguistic annotations as laid out in the ACADEMIC LICENSE.
2. The ADVISOR may only make the data available to a STUDENT who has signed a (Thesis) Project Non-Disclosure Agreement, which is provided as part of this (THESIS) PROJECT TERMS OF USE AGREEMENT.
3. The (Thesis) Project Non-Disclosure Agreement must be signed by the STUDENT.
4. The ADVISOR may only make the data available to the STUDENT on a computer network of their EDUCATIONAL INSTITUTION. STUDENTS may not copy any portion of the data to another location, nor make it available to any other parties by any means.

This (THESIS) PROJECT TERMS OF USE AGREEMENT shall be governed by German law, under Tübingen jurisdiction.
